All purchases from Pride Garden Products are made subject to these Terms and Conditions. Your submission of a purchase order or other authorization for products, or allowing us to ship products or commence work, will constitute your acceptance of all our Terms and Conditions.

Pricing

All listed prices are wholesale prices in US Dollars. Prices are subject to change without notice. All prices are FOB Pride DC.

At the time of your order, you will receive price of the ordered items and an estimated time and cost of delivery. An order confirmation will be sent via email and/or fax. Sales tax, if applicable, will be added to your invoice. If exempt, you should be able to produce an acceptable resale tax exemption certificate.

When applicable, extra charges (such as customs duties, import fees, special delivery requirements) will be your responsibility. We reserve the right to pass these costs on to you in the form of additional charges.

Ordering Minimums and Deposits

The majority of Pride Garden Products items require a minimum to purchase (frequently this will be a full pallet). Certain core items may be available in case quantities depending on inventory and time of year. Consult your representative for availability and product ordering specifics.

All orders are subject to acceptance by Pride Garden Products. All orders are firm once approved and may not be cancelled without our written approval. Deposits for cancelled product that has been produced will not be returned.

Items not in stock may require a 180-day lead time. We encourage you to place orders as early as possible in the summer and fall. Certain items may be sold in limited quantities and not available for re-order.

Credit and Payment Terms

Payment is due when the sales order is placed unless the customer has approved credit with an account in good standing. A deposit may be required for certain orders even if credit is granted. Payments can be made by cash, company checks and electronic fund transfers (EFT). Major credit cards for payments up to \$5000 are accepted with a 3% merchant fee.
